In order to maintain daily operations and patient care services, health care facilities need to develop an Emergency Water Supply Plan (EWSP) to prepare for, respond to and recover from a total or partial interruption of the facility's normal water supply. The EWSP should be a chapter in the overall facility emergency response plan and should be exercised on a regular basis and revised appropriately.



Our Program will help you observe the directions of the mandate for emergency preparedness and will demonstrate compliance to the water supply portion of your facility's emergency plan.





Our Nephros Point of Entry System is the ultimate barrier for your water applications, including potable water, cooling systems, closed loops, and other applications. The 304SS housing with a flush port holds six 20" clean in place 0.005 micron ultrafilters to allow for flow rates up to 30 GPM.
